espite a rainy summer, the RMIA Community Garden at LaPointe Park had another fruitful year. Cherry tomatoes and herbs seemed to be the most successful crops this year with the cool summer in Chicago this year. Despite having to share a few tomatoes with the squirrels, everyone was able to pick some produce.

This was the fourth year the RMIA has sponsored the Community Garden at LaPointe Park. The garden provides the opportunity for people from the Manor to be responsible for a plot to tend for the season. The garden organizers till the garden and prepare the soil and the gardeners bring their own seeds and plants and then water and weed until harvest. With all the rain, however, there was less watering in the garden this year.

Garden plots are assigned on a first come, first serve basis, with priority given to gardeners from the prior year. In the past two years, demand for plots has exceeded supply, so if you are interested in a plot reserve your space early. Manor Businesses Change with Times

The signs of economic change can be seen everywhere. While posted "for rent" signs are visible all over town, the Manor has several business success stories to crow about. Two familiar businesses leave for bigger opportunities and two new businesses open their doors in the neighborhood.

A fixture on Francisco Avenue since 2004, the **Go Get Your Smock! School of Art** has moved from a studio based program to an after-school program conducted on site at a variety of Chicago elementary schools including nearby Waters Elementary School. While on Francisco, GGYS provided art instruction for children, teens and adults. Beginning earlier this fall GGYS is now making an impact in multiple communities through its partnership with Chicago Public Schools.

Just up the street, **Kitchen Chicago** has recently left their Manor Avenue facility for hugely expanded space at 324 N. Leavitt Street. Kitchen Chicago provides a fully equipped, commercially licensed shared-use kitchen allowing its tenant-entrepreneurs to test menus, train staff, develop food products as well as produce the specialty foods currently sold in cafes, restaurants, markets and grocers throughout the Chicagoland area. Residents may remember when some of these delicious food items were available at KC's own café operated at the Manor facility back in 2005. The café was eventually closed as the floor space was needed for additional storage to support KC's rapidly expanding tenant list. With the opening of the Leavitt Street facility, KC has greater kitchen space and also now has a dramatic, two-story high, 2,000 square foot event space for rent to the general public.


While GGYS and KC are now gone, two new businesses opened in the Manor. Iron Cycles opened a corner storefont at 2860 W. Montrose Avenue and then recently moved further west to 3136 W. Montrose. Iron Cycles is a full-service bicycle shop. They can service and sell all types of cycles including children's bikes, full-fledged triathalon bikes, road racing and mountain bikes. Iron Cycles' business goal is to operate a shop that is welcoming to its patrons. The owners want to encourage lifestyles built around cycling to promote personal health and the betterment of the environment.

Also relatively new to the neighborhood is the office of **Urban Homes** at 4668 N. Manor Avenue.

Urban Homes, a residential real estate office, opened in 2008 to share its real estate knowledge and pro-

Manor Francisco Garden Update

In the spring of 2008, the Business District Committee proposed a landscape plan for nine new parkway gardens at the intersection of Manor and Francisco. Implementation was based on a three-phase installation. The first phase was budgeted at approximately \$7,500. Fundraising efforts began in the summer of 2008 but were temporarily suspended later that year due to the sudden downturn in the



economy. The fundraising efforts have remained frozen for most of 2009 but the Committee is planning to revisit the overall plan, the implementation strategy and the fundraising goals over the

coming winter. To date, more than \$1,800 has been raised towards the first phase.

The key first step of the overall landscape plan was the replacement of the existing sidewalks in the area. The Alderman's office provided assistance with this effort however inadequate drainage necessitated that some of the new sidewalks had to be re-worked. Again, through the involvement of the Alderman's office, those corrections have been made.

As part of the pedestrian improvements to the area, the Committee has also tried to create a new pedestrian textured crosswalk from the north tip of Manor Park to the east side of Manor Avenue. The Committee has also advocated repainting the existing textured crosswalks.

The scope of the 2008 landscape plan includes installing landscape timbers around the perimeters of each of the nine garden areas. The timbers would not project more than six inches above the ground in most locations so they would not be obstacles to swinging car doors. They would allow the interior of the planting beds to be leveled with new, high quality soil without covering the existing tree trunks with additional soil. In addition to the timber borders, the walkways on Francisco would be edged with "Holland Stone" pavers to provide more width for pedestrian movement between the curb and the sidewalk.

The plan calls for larger, sturdier plants to be installed near the corners of each garden to define the borders and protect the interior planting beds. To avoid a visually monotonous appearance, the plan calls for a variety of other plants to weave through the interior of each garden. These secondary plants would vary in height, density and seasonal display to provide a softer, more organic overall character to the gardens.

The landscape plan also includes "notched out" areas in the center of each of the new gardens along the adjacent sidewalk. These are the locations of future park benches to provide new seating opportunities for our residents to enjoy the new gardens. Currently there is no City funding to provide park benches but that will be the focus of future community efforts.

The plan was created by Landscape Designer, Marisa Gora of Kemora Landscape Designs who donated her time.
