Q&A: Manor Historic District

In 2008, following a nomination process directed by the RMIA, Ravenswood Manor was listed on the National Register of Historic Places. There are 520 buildings in the triangular-shaped historic district, whose boundaries are: Sacramento Avenue, the North Branch of the Chicago River, and the alleys south of Lawrence and north of Montrose avenues.

With construction season approaching, here are answers to some of the most-frequently asked questions regarding the historic district.

Q: What types of restrictions are there in a National Register district?

A: The simple answer: None. Unlike local landmark districts, which are designated by the City of Chicago, National Register listing does not require any review of local building permits, including alterations, demolition, new construction, etc. However, if a homeowner decides to take advantage of one of the economic incentives available to National Register-listed properties, the owner must go through a review process with the State of Illinois.

Q: What are the economic incentives available to property owners in the Ravenswood Manor National Register Historic District?

A: There are two primary incentives. The most applicable one for Manor homeowners is the "Property Tax Assessment Freeze," which enables eligible owners undertaking a significant rehabilitation project to have their property's assessed value "frozen" at the pre-rehab level for an eight- to 12-year period. The other incentive, the "Federal Historic Preservation Tax Credit," applies to owners of income-producing properties, such as an apartment building or commercial structure. This program enables a property owner to receive a 20% credit on their federal income taxes, as related to the eligible expenses of a major rehabilitation project. Important point: in the case of both incentive programs, you must apply—and receive an approval—before undertaking any rehab work.

Q. What types of restrictions apply to these incentives?

A. In addition to the eligibility requirements—which are spelled out in the application process—all of the rehabilitation work must meet the U.S. Secretary of the Interior's Standards for Rehabilitation. If the project does not meet these standards, the property owner will not be given the economic incentive (i.e., property tax freeze or federal income tax credit).

Q: How can I learn more about these economic incentive programs?

A: Both programs are administered through the State of Illinois Historic Preservation Agency. Its web site describes the programs in detail and gives property owners contact information. See https://www.illinois.gov/ihpa/Preserve/Pages/Funding.aspx. (continued on pg 2)

Q. How can I learn more about Ravenswood Manor's National Register Historic District?

Taking Root

Tree plantings north of Wilson

Do you need a tree to replace one that's been lost on the parkway in front of your house? Applications are being taken now for new tree plantings in our neighborhood, which is an effort being coordinated by the Manor Garden Club, the RMIA, and Openlands' TreeKeepers program.



Last fall, 20 new trees were planted on the streets south of Wilson Avenue. This spring, plantings will be focused north of Wilson. In honor of RMIA's 100th year anniversary, these will be known as "Centennial Trees." The RMIA Board has agreed to pay half of the cost of each tree; the other half will be paid for by the homeowner, who also agrees to help out on the tree planting day and to water and weed the tree(s) on their parkway. The Spring tree planting date has not yet been scheduled, but will likely be on a Saturday in late-April.

Manor neighbors—north of Wilson Avenue—who are interested in purchasing a tree for their parkway should send their name, address, and email to manorgarden_trees@comcast.net. I Am Curious (Manor)

Q: Is it true that an expressway once was proposed to run through Ravenswood Manor?


A: Strangely enough, that story is true. As part of the Chicago Plan Commission's Comprehensive City Plan map of 1946, a proposed new expressway route was shown along the North Branch of the Chicago River, stretching south from the intersection of Devon Avenue and McCormick Boulevard to Diversey Boulevard, where it would have connected to the Northwest Expressway (now Interstate 90/Kennedy Expressway).

According to news articles of the time, the expressway would have taken one of two different routes. The most prominent ran along the west side of the North Branch Channel and would have replaced most of the houses in the Manor between the river and Manor Avenue, before crossing to the east side of the river at Irving Park and back to the west side at Belmont. The second solution called for building the expressway over the river itself on an elevated bridge structure.

As you might imagine, the proposed expressway route was strongly opposed by the Ravenswood Manor Improvement Association, along with other neighborhood groups. In 1962, after the newlyformed North River Commission strongly opposed the project, it soon vanished from city transportation planning documents.



Tales of the Manor

Last year, as part of our Centennial celebrations, a neighborhood research committee conducted interviews with nine longtime Manor residents. The audio recordings of those interviews are now available on the RMIA web site at http://ravenswoodmanor.com/stories/.

The committee first identified residents who had at least a 50-year connection to Ravenswood Manor (e.g., one resident has lived here since 1924). The interviews, each 40 minutes in length, were then recorded on equipment loaned to RMIA from StoryCorps, a national organization. As a result, each of the recordings is now on file at the American Folklife Center at the Library of Congress.

The subjects of the interviews were: siblings Peg and John Byrne, Adrian Collins, Dick Lanyon, siblings Beth Newell Murphy and Susan Newell O'Connell, Ruth Robbins, and spouses Don and Eileen Valentin. Do-it-Yourself Hawks Pub Crawl

As the National Hockey League enters its long playoff season, consider organizing your friends and neighbors for a "Hawks Pub Crawl," utilizing some of our area's bars and restaurants. Below are a few sample itineraries, each of them grouped according to the three periods of a hockey game—the idea being that you can walk to the next location during the breaks between periods.

Manor Crawl: Start with dinner at Golden Crust Pizza, 4620 N. Kedzie. Then, following the first period, move on to Templestowe Pub, 3135 W. Montrose. Finish the game at the Montrose Saloon, 2933 W. Montrose.

Gardens Crawl: Start at the Rockwell Grill, 4632 N. Rockwell; move on to Time Out Sports Bar, 4641 N. Rockwell; and finish (with a Philly cheese steak) at Monti's, 4757 N. Talman.

Lincoln Square Crawl: Start at Lincoln Square Lanes, 4874 N. Lincoln (consider pre-game bowling and/or food), then head south on Lincoln to Carola's Hansa Clipper, 4659 N. Lincoln, and finish at Ricochet's 4644 N. Lincoln or Daily Bar & Grill 4650 N. Lincoln.

Obviously, there are dozens of other variations, especially if you utilize the "L" to start and finish your crawl near the Western, Irving Park, or Southport stations. One final tip: Consider a non-Saturday night game to avoid the biggest crowds. Go Hawks.

Wanted: Court Advocates

The 17th District Court Advocacy program plays an important role in making our neighborhood safer. It requires more than good police work to make a neighborhood safe. It also takes the police, the community, and city agencies—all working together—to really make a difference.

With input gathered at police beat meetings or from community residents, the Court Advocacy subcommittees, working with the Chicago Police Department, help identify and track cases of interest to the community. Volunteers then attend court dates associated with those cases. It's as simple as that. An example of a current case requiring Court Advocacy volunteers is the infamous recent machete attack at the Kedzie Brown Line stop.

The presence of Court Advocacy volunteers sends a strong message to the defendant, the judge, and all the other interested parties in the criminal justice system, which is: The community cares about the outcome of a case and is willing to devote its time and energy to monitoring the workings of the judicial system.


